How a Non-Owner SR22 Is Structured

The design of a non-owner policy differs enough from standard auto insurance to be worth stating precisely.

The structure

A non-owner SR22 is a liability-only policy that follows you, the driver, instead of a specific car.

Your insurer files the SR22 with the Indiana BMV from that policy.

The inversion

Ordinary auto insurance attaches to a vehicle and extends to whoever is properly driving it. The car is the insured object; the driver is a variable.

A non-owner policy reverses that relationship. You are the insured party, and the vehicle is the variable.

Why this matters

Every other characteristic of these policies follows from that inversion.

The coverage travels with you rather than remaining with a vehicle. It applies across different cars rather than one. And it exists at all because the state's requirement attaches to a licence rather than to a car.

For drivers who assumed an SR22 obligation required owning something to insure, this is the product that resolves the apparent contradiction. There is no need to acquire a vehicle in order to insure one.
